## **Session Tracks**

## **Best Practice in Early Care and Education**

Sessions in this track will focus on positive teacher/child interactions, setting positive climate and linking curriculum to CLASS domains. These sessions will address all three care levels, Infant, Toddler Preschool/Pre-K.

# **Trauma- Informed Care**

This track will focus on the basics of early childhood mental health and teacher well -being while providing resources to educators and program leaders. Sessions will explore working with children and by extension their families who have experienced trauma. In addition, sessions will touch on self-care for educators and how that plays a part in the learning environment.

# **Transitions in Early Childhood**

This track will empower program leaders and educators to create a culture of school readiness in their programs. Transitions in Early Childhood will view readiness from several different lenses: 1) the use of developmental standards as a resource 2) engaging and supporting families through their child's transition and 3) preparing preschools for transitioning to kindergarten.

# <u>Child Development</u> – ASQ, ASQ-SE, GOLD, Galileo, CORE

This track unpacks child observations and developmental screening tools. Teachers will learn the benefits of ongoing observation and documentation which, together, build a full picture of each child 's needs. Sessions will provide exposure of various tools as a resource for communicating with families and help enhance learning in the classroom
